






INDIA-MALAYSIA BILATERAL TIES (TRADE OVERVIEW 2025)

MIBC has lived up to its principles and objectives in strengthening the bond between Malaysia and India especially in trade, investments and services.



Bilateral Trade



- For FY 2023-24, bilateral trade (Malaysia to India + India to Malaysia) was about **US\$ 20.01 billion**.
- India's exports to Malaysia for FY 2024-25 are about **US\$ 7.32 billion**.
- For FY 2023-24 the total bilateral trade (again) ~US\$ 20.01 billion, so India → Malaysia imports can be inferred as roughly US\$ (20.01 billion minus ~12.54 billion) ≈ **US\$ 7.47 billion**.
- In 2022, India's exports to Malaysia were ~US\$ 7.19 billion.
- One breakdown: India's imports from Malaysia in FY 2024-25 (i.e., Malaysia's exports to India) stood at approximately **US\$ 12.54 billion**.
- For earlier years: In 2022, Malaysia's exports to India were around **US\$ 12.42 billion**.

- On 19 August 2024, the 9th Malaysia-India CEO Forum was held in New Delhi, co-chaired by Nikhil Meswani and Tan Sri Ir. Kuna Sittampalam, under the auspices of the Malaysian Prime Minister's visit to India. The Forum presented its report and recommendations to both governments and coincided with eight MoUs spanning key sectors such as workforce mobility, digital technologies, culture / tourism and governance reform. This event underscores MIBC's central role in driving Malaysia-India business cooperation in the new era of the Comprehensive Strategic Partnership.
- Major Highlights and Outcomes:
 - The Forum was convened in conjunction with the official visit of the Malaysian Prime Minister to India (19-21 August 2024)
 - The Co-chairs presented the Forum's report and key recommendations to the Indian and Malaysian governments: to India's External Affairs Minister S. Jaishankar and to Malaysia's Minister of Investment, Trade & Industry Tengku Datuk Seri Utama Zafrul Tengku Abdul Aziz.
 - The Forum served as a high-level business-government interface reaffirming the strategic importance of Malaysia-India economic ties under the new era of the bilateral relationship (shortly after elevation to a Comprehensive Strategic Partnership).
